Australia's Aged Care System Review - Caring for Older Australians

The Productivity Commission invites interested parties to register their interest in an inquiry into Australia's aged care arrangements.

In undertaking the inquiry, the Commission will develop options for further structural reform of the aged care system so it can meet the challenges facing it in coming decades. In particular, the Commission will:

- examine the social, clinical and institutional aspects of aged care in Australia, building on the substantial base of existing reviews into this sector
- address the interests of special needs groups
- develop regulatory and funding options for residential and community aged care (including the Home and Community Care program)
- examine the future workforce requirements of the aged care sector
- recommend a path for transitioning from the current regulatory arrangements to a new system that ensures continuity of care and allows the sector time to adjust
- examine whether the regulation of retirement specific living options should be aligned more closely with the rest of the aged care sector
- assess the fiscal implications of any change in aged care roles and responsibilities.

In the course of the inquiry, the Commission will consult widely with older Australians, their carers, aged care providers, government agencies and other interested parties.

Funding boost and less red tape for Australian Disability Enterprises

Australian Disability Enterprises (ADEs) will receive an additional \$4.5 million in 2010-2011 to allow them to continue to support over 19,000 workers with disability across Australia who would not otherwise be able to find work.

The Australian Government funds 600 businesses operated by 206 organisations across the country to provide supported employment opportunities for people with disability. The Minister for Families, Housing, Community Services and Indigenous Affairs, Jenny Macklin said Australian Disability Enterprises had a vital role providing work and training for people with a disability.

'The Government understands that ADEs are under significant pressure which is why we are providing an additional \$4.5 million to support them continue to employ people with a disability during difficult economic times.' The extra funding is in addition to \$9 million provided in 2010-11 to maintain a temporary increase made by the previous Government.

Parliamentary Secretary for Disabilities and Children's Services, Bill Shorten said ADEs made a huge difference in the lives of people with disability. A job is the key to social inclusion for people with disability. It provides financial independence, the chance to make a contribution to society and the camaraderie of the workplace,' Mr Shorten said.

This additional funding, allocated from within the disability services budget, brings total Australian Government support for ADEs to more than \$204 million in 2010-2011. The Government will continue to listen to and work with the ADEs to support them in providing benefits to people who would otherwise be excluded from the workforce.

The Government will also introduce a 12-month red-tape reduction trial that will reduce the amount of time Australian Disability Enterprises spend assessing the support needs of their employees through Disability Maintenance Instruments, by only conducting re-assessments under certain circumstances, rather than every two years.

Under this trial, re-assessments need only be undertaken by an Australian Disability Enterprise where there is a significant change in the worker's health status, stamina or physical capacity; where there is a profound change in disability that affects work performance or where there is a significant change in the worker's personal circumstances.

The Department of Families, Housing, Community Services and Indigenous Affairs will also be able to request an assessment by an ADE, as will workers and their families. 'This decision will deliver significant savings to the sector and make it easier for Australian Disability Enterprises to continue the great work they do giving people with disability the benefits of meaningful employment,' Mr Shorten said.

Ken Baker, the Chief Executive of National Disability Services, the peak association representing non-government disability services, has welcomed the measures.

2010 Human Rights Medals & Awards: nominations open

Nominations are now being called for the Australian Human Rights Commission's 2010 Human Rights Medals and Awards.

Commission President, Catherine Branson QC, has called for individuals and organisations around Australia to nominate for the Medals and Awards which recognise and reward efforts to protect human rights in Australia. "For one day of the year, the annual Human Rights Medals and Awards shines the spotlight on the efforts people are making on a daily basis to strengthen Australia's human rights culture," President Branson said.

"These efforts impact on us all and ultimately contribute in some way to making Australia a safer and more inclusive society. "Whether it be by actively working to reduce discrimination in workplaces or communities, supporting individuals or organisations to protect their rights, or whether it is by influencing law and policy to provide a fairer Australia for us all, human rights heroes are everywhere," Ms Branson said. "The annual Human Rights Medals and Awards is an opportunity to applaud their efforts and to say thank you."

Nominations can be made for the Human Rights Medal and Young People's Human Rights Medal and seven Award categories: Law, Community (Organisation), Community (Individual), Literature (non-fiction), Print Media, Television and Radio.

The Australian Human Rights Commission has a web-section containing all the information about the 2010 Human Rights Medals and Awards, including Award categories, how to enter, judging criteria, previous winners and how to buy a ticket to the awards ceremony.

There's also a section for media, with the latest news releases, and information about the sponsors for this year's Award ceremony which are: Rio Tinto; the Department of Immigration and Citizenship; the Law Council of Australia; iHR Australia; Avant Card; Trophyland; The Co-op Bookshop; Online Opinion and Vibe Australia.

Nominations close at 5pm on Monday, 4 October, 2010. Winners will be presented with their Medals and Awards at a ceremony to be held on Human Rights Day, Friday, 10 December 2010 at the Sheraton on the Park in Sydney.

Vision Australia's Further Education Bursaries

Each year Vision Australia awards financial bursaries to tertiary students who are blind or have low vision for the purchase of adaptive technology such as CCTVs, laptops, screen reading and magnification software. Vision Australia's Further Education Bursaries aims to assist clients who would not otherwise be able to afford adaptive technology, thus increasing their ability to participate in further education. Since 1996, 191 bursaries have been awarded by Vision Australia to students studying a broad range of disciplines - from Arts and Music to IT and Business.

To be eligible, applicants need to:

- * Be an Australian citizen or permanent resident of Vic, NSW, ACT, Qld, the NT or Tas.
- * Be (or become) a client of Vision Australia
- * Demonstrate the need for financial assistance to purchase adaptive technology
- * Be applying for, or enrolled in, a tertiary course graded Certificate IV or above
- * Be available to attend a presentation ceremony in May.

To apply for a bursary, applicants need to:

- Complete an application form - download available from August at www.visionaustralia.org/bursary
 - Have an adaptive technology assessment specifically for the Bursary with a Vision Australia consultant
 - Provide some documentary evidence (outlined on the application form).
- (Applications are treated in the strictest confidence.)

Important dates: Applications open in August and close at the end of October. Recipients are selected in December, equipment is purchased and delivered after proof of enrolment has been provided (around March) and the Bursaries are presented at ceremonies in May.

NSW Disability Services Sector – Directions for Industry Development Final Report Released

NDS and ADHC release a major report setting clear direction for building the capacity of the not for profit disability sector in NSW. The report [NSW Disability Services Sector: Directions for Industry Development Final Report](#) [PDF 878KB] represents the culmination of extensive consultation with relevant stakeholders, and details strategies and actions over the next 5 years.

The NSW budget for 2009-10 announced \$17 million to establish an Industry Development Fund (IDF) to be used by the sector to build the capacity and sustainability of services and to revolutionise the way in which services are accessed by, and provided to people with disability.

In late 2009 **National Disability Services NSW** in partnership with **Ageing, Disability and Home Care, Department of Human Services** brought together advocates, peak bodies, service providers and policy makers to develop a vision and direction for disability services into the future.

This report is the first step in setting out a truly strategic focus for the sector in collaboration with the NSW Government, moving us beyond the funding relationship into a partnership that is focused on supporting people with a disability, their families and carers, and placing them firmly at the centre of service delivery.

The report highlights six areas of focus:

- People with disability at the centre of service delivery
- People with disability have access to the information and range of supports they need to live the lives they choose
- High-performing organisations achieving real outcomes for people with disability
- Robust planning and resource allocation decisions based on accurate data and evidence
- Effective governance, leadership and management of the sector
- The workforce is skilled, capable and focused on people with disability

The Home Medicines Review (HMR) was introduced into the Medical Benefits Scheme in October 2001 to increase the appropriate use of medications and reduce the incidence of 'medication misadventures', thereby assisting in improving patient health outcomes.

The HMR is a consumer-focused, structured and collaborative health care service provided in the community setting to optimise consumer understanding and quality use of medicines. It involves the consumer, their general practitioner, their pharmacy, and other relevant members of the health care team. This information has been developed to highlight the evidence around the use of HMRs and to assist health providers to target those consumers who will gain the most benefit from a review of their medicine.

Mental health services in Australia 2007-08

Mental Health Services in Australia 2007-08 is the twelfth in the series of annual reports providing a detailed picture of the national response to the mental health care needs of Australians. Details from a wide range of data sources for the 2007-08 period, and where available 2008-09, are presented, as are changes over time. Expenditure on state and territory mental health services has been increasing on average by 6% per year (adjusted for inflation) since 2003-04, states and territories spent \$3,323 million on these services in 2007-08. There were 4.6 million Medicare claims for subsidised psychiatrist, psychologist and other allied health professional services in 2008-09, an increase of 17.4% from the previous year. New booklet to help women with intellectual disability learn more about their health

NSW Health has launched a new booklet to support the health of more than 70-thousand women living with intellectual disability in NSW. The book *Being a Healthy Woman* is designed to assist women with an intellectual disability who are often less likely to understand life changes, the importance of a healthy lifestyle, or the need to see doctors when ill.

The *Being a Healthy Woman* book is written in simple and accessible language which will improve communication between medical professionals and women with intellectual disabilities.

The book was produced by the Centre for Education and Research on Ageing after extensive consultation with women with intellectual disabilities, their families, carers and support workers.

It covers sixteen topics including being healthy and happy, growing up, safe sex, parenting, breast health, dealing with grief and loss and growing older. *Being a Healthy Woman* is backed by a training package that has been trialled by GPs and hospital registrars to improve the health outcomes for women with an intellectual disability.

The package was developed by GP Synergy and it is based on work done by Centre for Developmental Disability Health Victoria.

“The *Being a Healthy Woman* book is complemented by this training package which is available on DVD or in a power point presentation to address communication barriers medical professionals may have in effectively working with women with intellectual disabilities,” Ms Lynch said.

“The book also contains an extensive list of health resources and where to find them which will help women with intellectual disabilities, family members and medical practitioners seeking more detailed information.”

It can be used by any training facility and may be modified for training to any group.

Family Planning, Centre for Disability Studies, NSW Council for Intellectual Disability and Department of Education have indicated an interest in the training package to address families, carers or teachers. The training package will be available on the GP Synergy website.
