Productivity Commission Draft Report on Disability Care and Support

The Commission was asked to examine the feasibility, costs and benefits of replacing the current system of disability services with a new arrangement that provides essential care and support for all Australians in the event of significant disability. The draft report was released on 28 February 2011. **You are invited to examine this report and make written submissions to the Productivity Commission by 30 April 2011.**

In the preamble they state - “The disability support ‘system’ overall is inequitable, underfunded, fragmented, and inefficient and gives people with a disability little choice. It provides no certainty that people will be able to access appropriate supports when needed. While some governments have performed much better than others, and there are pockets of success, overall no disability system in any jurisdiction is working well in all of the areas where change is required.

The central message of this draft report is that a *real* system for people with a disability is required — with much more and better-directed money, a national approach, and a shift in decision-making to people with a disability and their carers. This overview explains what is wrong with the current system and how to improve it. It shows how a new system would work for individuals with a disability and their families, and how it would provide benefits for the community as a whole.

Some of the key points are:

- The current disability support system is underfunded, unfair, fragmented, and inefficient, and gives people with a disability little choice and no certainty of access to appropriate supports.
- There should be a new national scheme — the National Disability Insurance Scheme (NDIS) — that provides insurance cover for all Australians in the event of significant disability.
- The NDIS would fund long-term high quality care and support (but not income replacement). Around 360 000 people would receive scheme funding.
- The needs of people with a disability and their carers would be assessed rigorously by NDIS-appointed local assessors. Assessment would lead to individualised support packages.
- The agency overseeing the NDIS — the National Disability Insurance Agency — would be a federal agency created by, and reporting to, all Australian governments.
- The Commission’s preliminary estimates suggest that the amount needed to provide people with the necessary supports would be an *additional* \$6.3 billion, roughly equal to current funding.
- The Commission is proposing that the Australian Government take responsibility for funding the *entire* needs of the NDIS.

On 23 December, the European Union (EU) ratified the CRPD, becoming the first intergovernmental organization to join a United Nations human rights treaty. The EU ratification (or "confirmation" in the wording of the CRPD) is based on article 42 of the CRPD, which states that the Convention is also open for signature by regional integration organizations. The EU first committed to joining the CRPD by signing it in March 2007. The ratification of the CRPD by the EU represents a significant commitment to raising awareness on the rights of persons with disabilities, mainstreaming disability rights across all areas of EU competency and taking concrete steps towards ensuring that the rights of persons with disabilities in society and development are respected, protected and fulfilled.

Age Discrimination – exposing the hidden barrier for mature age workers

Since the introduction of the *Age Discrimination Act 2004* (Cth), experiences of age discrimination in employment among mature age workers have featured prominently in the complaints of age discrimination received by the Australian Human Rights Commission.

A number of general themes emerged including mature age workers' access to appropriate skills and training, the ability to balance unpaid caring work, issues of law reform and the lack of detailed Australian research into these issues. One of the foremost barriers that emerged was that of unlawful age discrimination - and this in the face of one of the most significant demographic shifts in modern human history where populations across the globe are ageing.

Age discrimination is entrenched through ageism, which can be found in almost every sphere of public life. It doesn't just exist - it thrives. Disturbingly, unlike other forms of discrimination, age discrimination and ageism don't yet seem to be at the point of being stigmatised.

The purpose of this paper is to look at and raise awareness of the issues of ageism and unlawful age discrimination against mature age workers within the workplace. It is a form of discrimination that appears to sit quietly – it can go unnoticed and seems accepted. This paper aims to expose it.

Effective assessment of social isolation A/Professor Jan Sansoni University of Wollongong, Centre for Health Service Development This project reviewed the scientific and 'grey' literature concerning instruments used for the effective assessment of social isolation. The research initially identified 155 assessment instruments and used an evaluation framework to identify the most promising instruments for comprehensive review. Four instruments were selected: De Jong Gierveld Loneliness Scales; the Lubben Social Network Scales; the Multidimensional Scale of Perceived Social Support and the Medical Outcomes Study Social Support Survey for further testing and linguistic validation.
